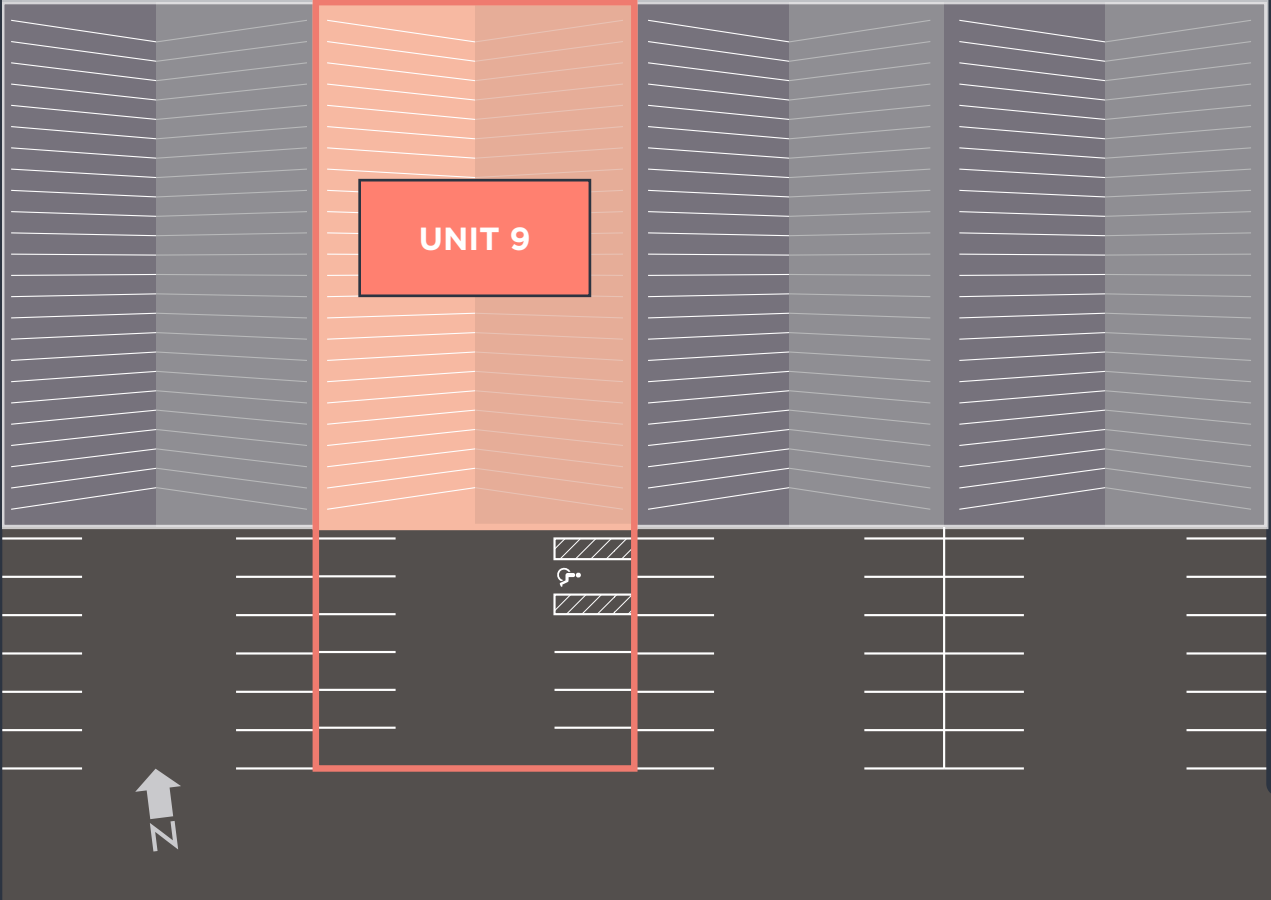
DESCRIPTION

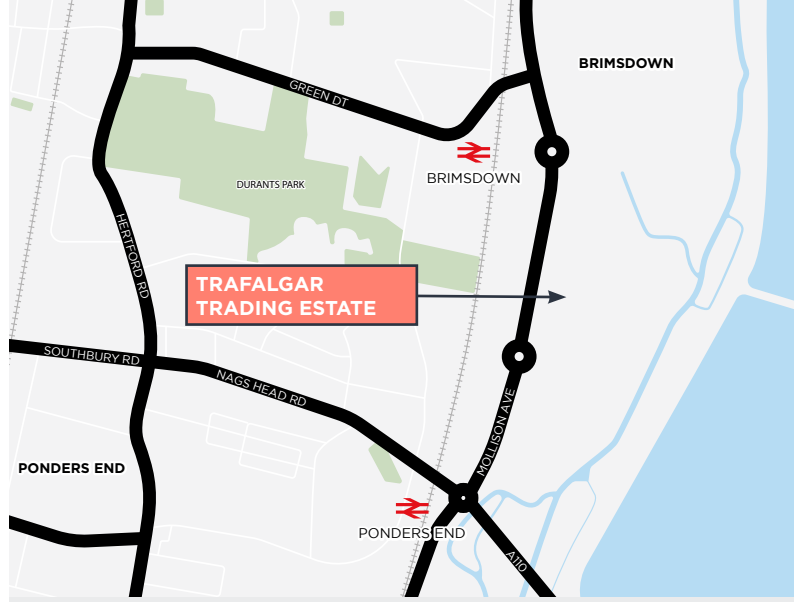
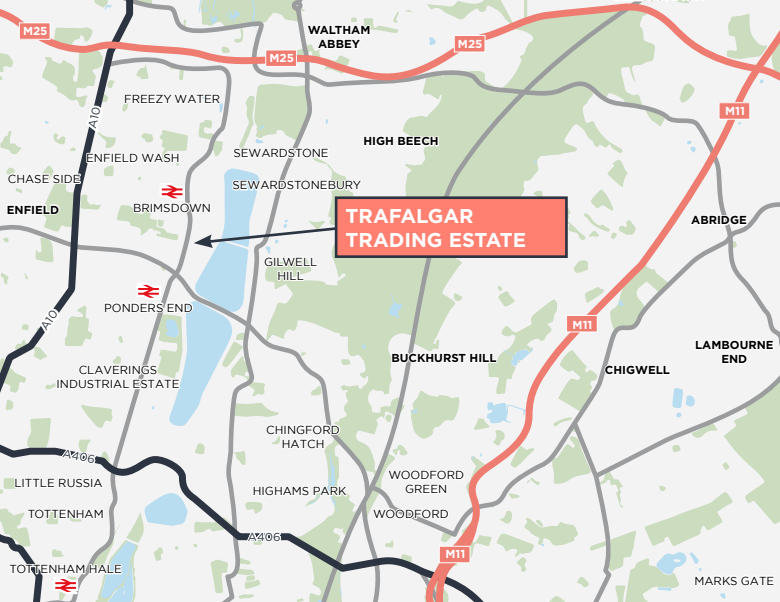

LOCATION

Trafalgar Trading Estate is located at the junction adjoining Mollison Avenue and Jeffreys Road, found in the Brimsdown Industrial Estate, Enfield. This is a prominent location with great visibility for passing traffic.
